Footnotes

CAT CAN DO was reserved in early stages and settled in stalking the early pace, steadily began to gain position in the backstretch, raced three wide into the turn, given cue midstretch and kicked by rivals late. BLUE GRASS MUSIC raced just off the leader in opening stages, made a bid between rivals in the turn, vied for lead going into the lane, took command briefly and was caught in late strides. COOL CAROLINA allowed to settle in opening stages, continued patiently in the backstretch, made a bid in the upper stretch and gained ground to the wire. BLUSHING TIGER was unhurried in the backstretch, saved ground racing along the rail in the far turn, continued within contention in the upper stretch and lacked final kick to make serious impact. SARATOGA BLITZ duelled along the inside for the lead in opening stages, took command by a steady margin, challenged by rivals nearing the far turn, vied into the lane and could not match strides in the late stretch. TWILIGHT STORM tracked the pace in early stages, asked to pick up the pace going into the turn, slightly gained position and flattened out shortly after. DESERT WITCH tracked the pace in early stages, began to advance position along the outside in the backstretch, raced three wide into the turn and came up empty in the late drive. SACRED DESIRE raced evenly near the back of rivals and lacked response in the drive. ALTAMAR vied for the lead in the opening quarter, could not match strides with rival and slightly settled back and had nothing left entering the top of the stretch. BOB'S JAWBREAKER trailed throughout and failed to make a bid.
