MAJESTIC HUSSAR took command by a narrow margin in opening stages, continued to set the pace near the inside in the backstretch, raced four wide into the lane and remained clear. PALACE MALICE tracked just off the pace in early stages, asked to make a bid for leader nearing the far turn, shifted out five wide in the turn, continued to chase MAJESTIC HUSSAR into the stretch and finished clearly second best. CITY OF WESTON stalked between rivals in opening stages, asked to pick up the pace heading into the far turn and continued an even bid in the stretch. ROAD AGENT raced just off the pacesetter in opening stages, continued to track the pace in the backstretch, continued within contention in upper stretch and flattened out in the drive. D'NIED PERMISSION settled along the inside in the backstretch, raced between rivals going into the turn and continued along the rail in the drive. ALL KEYED UP was reserved in opening stages and settled in the back, slightly gained position nearing the turn, raced four wide into the lane and lacked response late. JAY EYE SEE stalked the pace in the backstretch and began to weaken after a half mile. PEPE made a bid for the pace in opening stages and had little left after a half mile.
