Footnotes

LENTENOR stalked the pace, moved to take over leaving the far turn, then drew clear under urging. PERSON OF INTEREST unhurried after being steadied in the early going, advanced along the inside to reach the attending position inside the eighth pole but couldn't stay with the winner while saving the place. BIGSHOT rated off the pace, advanced into contention three wide around the far turn but couldn't get to the winner while closing to just miss the place. ALCOMATCH allowed to settle, steadied and swerved out to avoid PARTHIAN leaving the far turn, then finished willingly. ROCK AMERICA reserved early, circled rivals five wide to reach near even terms for command racing into the stretch, then tired. ONE SKY stalked the pace along the inside, was checked to avoid running up on the fading DIXIE SUMMER'S leaving the far turn and failed to recover. CHRISTOPHER'SIMAGE was not a factor. PARTHIAN well placed while saving ground, clipped heels with ONE SKY leaving the far turn and faltered. QUANDO QUANDO steadied from close quarters soon after the start and was outrun. RASCALLION tracked the pace for a half mile, then had nothing left. DIXIE SUMMER'S set the pace along the

rail to nearing the stretch, then faded. SARKAR steadied in the early going, was through after a half mile and eased in the stretch run. There was a stewards inquiry into the incidents leaving the far turn. No action was taken.
