FLY SOUTH vied for the lead through the half, was four wide in the final turn, gained command in the early stretch run and drew off. HYPHEN races up close to the leaders throughout, went two wide in the final turn and was a game second. QUICK APPEAL raced in the back of pack, was unhurried early, went three wide in the final turn and closed fast in the late stretch run. JILLUKE raced in the back of the pack and made a steady advance. NANA'S APPEAL rushed to the lead out of the gate, set the pace and weakened in the mid stretch run. RUBY'S RED SOCKS contended with the leaders throughout race and failed to respond. OF ALL TIMES was in contention throughout race and faded in the mid stretch run. EL GOLEM (ARG) passed tiring rivals and was no factor. ENORMISO raced in the middle of the pack and steadily retreated. STARSHIP STEVE race erratic and finished up at the back of the pack.
