Footnotes

CHARMING KITTEN was never far from striking distance, tracked the pace two off the inside in opening stages, set sights on the lead nearing the far turn, raced along the inside, edged up to the lead, vied with rival into the lane, was able to grab the lead by a slight margin and remained clear under strong hand ride. BAMBAZONKI tracked the pace along the rail in early stages, began to pick up the pace nearing the far turn, angled out slightly in the far turn, vied. REDWOOD KITTEN set the pace by a narrow margin in early stages, challenged by rivals going into the far turn, began to weaken in the upper stretch and slightly dug back in and held show position in late stages. SATURDAY SPECIAL settled and stalked the pace along the inside in early stages, steadily gained position along the rail in the backstretch, saved ground racing along the rail in the turn and flattened out in the late drive. FIRE GUARD stalked the pace in early stages, swung out four wide in the far turn and lacked final kick in the drive. SUMMIT COUNTY was unhurried in opening stages and settled in tracking the pace, urged for response nearing the far turn and lacked response in the drive. PRADO CAT raced behind the leader in early stages, edged up to the lead leaving the backstretch and could not sustain bid in the uppers stretch. FLYING BIRD lacked speed in early stages and raced in the back of rivals, continued reserved heading into the far turn and lacked response in the stretch.
