Footnotes

CENTER DIVIDER stalked the pace off the rail, was steadied to avoid RONIN DAX entering the far turn, rallied to gain a slim lead racing into the stretch, then vied with MOBILIZER through the stretch and prevailed. MOBILIZER rated off the pace, steadied racing down the backstretch, eased out to rally three wide around the far turn to reach CENTER DIVIDER, then vied with that rival through the stretch and was edged to the wire. CRIMSON CHINA reserved off the pace, advanced three wide around the far turn to reach contention, then couldn't stay with the leaders in early stretch and didn't do enough late. DUCDUC chased the pace, moved to take over soon after entering the far turn and eased to the inside, made the pace to nearing the top of the stretch, then gave way. DERBY KITTEN allowed to settle, steadied on the far turn avoiding RONIN DAX and failed to menace. LIGHTHOUSE SOUND was not a factor. TRUST THE DEPUTY reserved racing along the inside, faltered in the drive. RONIN DAX set the pace along the rail, then was checked to avoid coming out into DUCDUC entering the far turn and faded.
