ANGEL'S SEA stalked the pace three wide in early stages, asked to pick up the pace leaving the backstretch, angled out in the far turn, shifted inside in upper stretch and edged by foe under brisk right handed encouragement. DISTINCTIVE PIC rushed up to take the lead in opening quarter, continued to set the pace by a secure margin in the backstretch, was challenged by ANGEL'S SEA midstretch, could not hold off rival and finished clearly second best. SHERIFF IRA raced behind the pacesetter in early stages, raced between rivals rival near the quarter pole, swung out four wide into the lane and continued a steady even bid in the drive. BRACKET BUSTER settled in along the inside in the backstretch, saved ground racing along the rail in the far turn and failed to kick in the drive. ELISSA'SROYALIMAGE stalked the pace in the backstretch, urged left handed heading into the far turn, drifted out five to six wide and finished evenly in the drive. UNO AGAIN settled in near the back of rivals in early stages, swung out four wide into the lane, slightly gained position but failed to be a threat to the leaders. ULTIMATE CHOICE settled in along the rail and stalked the pace in early stages, made a bid heading into the far turn, slightly gained in the upper stretch and flattened out shortly after. DIAMOND SHOWCASE raced near the back of rivals in the backstretch and failed to rally in the stretch. EL COBRE lacked speed in early stages and raced in the back of rivals and failed to respond in the stretch. DONT MESWIT GOLDIE chased the pace between rivals in early stages, faltered after the half and was eased up in the stretch.
