Footnotes

MONUMENT HILL stalked the pace three wide, rallied to take over inside the eighth pole, came in for a step inside the sixteenth pole and edged away. CLEAR ATTEMPT rated off the pace, advanced into contention around the far turn, then lacked room in behind rivals in the stretch, recovered and closed to be up for the place. MINNIE PUNT reserved off the pace, rallied to loom a threat in midstretch but couldn't sustain his bid. EXCHANGING KISSES chased the pace, moved to take over on the far turn, made the pace to inside the eighth pole, then was being outfinished when steadied from inside MONUMENT HILL late and gave way. MIDDIE allowed to settle after being steadied in traffic on the first turn, closed with a mild response. TELLUM BERTO set the pace along the rail into the far turn, then tired. GROOVY SOUL unhurried after breaking slowly, saved ground, advanced to reach contention in midstretch, then flattened out. CLOSE IT OUT off slowly, was outrun early, swung wide for the stretch run and failed to menace. RELAMPAGO broke slowly, tracked the pace into the far turn and had no response when asked. MEGALITH stalked the pace three wide into the far turn and tired. THE RIDER OF EXCHANGING KISSES LODGED AN OBJECTION AGAINST THE RIDER OF MONUMENT HILL FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
