Footnotes

LODGE HILL reserved while saving ground, steadied and angled out at the top of the stretch for racing room, then rallied under pressure to be just up at the wire. FLAMIN' JOLIE well placed in behind the leaders, angled out in early stretch, rallied to gain a slim lead nearing the finish but was edged to the wire. SEATTLE NIGHT allowed to settle, swung out for the stretch run and closed well for the show. STAR OVER THE BAY stalked the early pace, moved up to vie for the lead after six furlongs, continued on well to deep stretch and gave way. A. P. DELTA saved ground into the stretch and lacked the needed late response. PERFECT STRANGER unhurried early, was steadied in traffic while attempting to rally in the stretch and failed to threaten. WHITTON COURT (IRE) vied for the lead outside VIVA PENTELICUS, responded when challenged by STAR OVER THE BAY, continued to vie for the lead to inside the eighth pole and weakened. WORLDWIND ROMANCE was not a factor. SILVER BISHOP reserved off the pace, raced three wide on the final turn and lacked a rally. GIMME STEAM was outrun and returned lame. VIVA PENTELICUS showed speed inside WHITTON COURT, eased back to chase the pace after a half mile, saved ground to the top of the stretch and faltered. RAPID RYAN raced in striking position, then was steadied from tight quarters at the top of the stretch and faded.
