Footnotes

HYPNOTIST steadied in behind SEA PLEASURE on the first turn, tracked the pace while saving ground, came out and split rivals to take over just inside the eighth pole and was fully extended to prevail. WHITE CAT tracked the pace three wide into the stretch, then responded to pressure and finished willingly to just miss. PRIVATE GOLD reserved after hitting the gate at the start, swung out for the stretch run and closed with a belated rally for the show. SUPER FROLIC unhurried early, raced three wide on the far turn, then swung out wide for the stretch run and was gaining on the top ones at the finish. SEA PLEASURE steadied in behind MILLENNIUM STORM on the first turn, prompted the pace outside that rival, moved to gain a slim lead in the stretch, then weakened. KING CASSIA raced in striking position into the stretch and lacked a late response. UNBRIDELS KING reserved early, advanced along the hedge around the far turn and into the stretch to reach contention, then couldn't gain late. STRIZZI allowed to settle, gained some ground in the drive without threatening. MILLENNIUM STORM outran SEA PLEASURE for the lead around the first turn, angled in leaving the first turn putting that rival in tight, made the pace along the hedge to midstretch and gave way. MAGIC MECKE well placed while racing three wide into the stretch, tired. ONE COLONY was outrun. FRED N ANNIE was through early.
