Footnotes

PUT HER BACK ZACH chased the pace, eased three wide to make a run at CORINTHIA, was forced wide by that rival at the top of the stretch while moving to gain the lead, then drew clear through the final eighth under urging. CORINTHIA showed speed off the rail, then drifted out into PUT HER BACK ZACH at the top of the stretch and couldn't stay with that rival in the drive while clearly second best. SYDNEY RULES reserved along the inside, couldn't keep pace with the top ones while gaining the show. NEVADA JAK unhurried after being bumped and squeezed back from between horses at the start, passed tired rivals. GOLD KNIFE was no factor after being steadied when she bumped with NEVADA JAK at the start. COPLA DE ORO rated off the pace, tired. NORTHWEST WOODS was outrun after being steadied at the start. MARIA'S EYES tracked the leaders three wide to midway of the turn, then faltered. QUILCHENA saved ground to no avail. ELEGANCE GIRL showed little after bumping with NEVADA JAK at the start. SHESWONHOTMAMA pressed the pace three wide into the turn and faded. THE TRAINER OF CORINTHIA LODGED AN OBJECTION AGAINST THE RIDER OF PUT HER BACK ZACH FOR ALLEGED INTERFERENCE AT THE TOP OF THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
