Footnotes

SNUCKOUTATMIDNITE rated off the pace, angled outside the leaders in early stretch, rallied to gain the lead inside the eighth pole, then was all out to last over WORKING MAN BLUES. The latter, tracked the pace after breaking slowly, angled out for the drive and rallied to just miss. THUNDER ALLEY unhurried early, closed well through the stretch to just miss the place. WISE ESCAPE chased the pace three wide, rallied to gain a brief lead at the eighth

pole, then drifted in impeding SCARBUM and was outfinished. SCARBUM reserved early, advanced to loom a threat in midstretch, then was checked just inside the eighth pole when shut off by WISE ESCAPE and failed to recover. PERI PERI outrun early, closed with a belated rally. DONT POKE THE BEAR pressed the pace outside STANCO, took over from that rival leaving the far turn, made the pace to nearing the eighth pole, then tired. HIGH END PROSPECT failed to menace. STAY OUT FREDDIE was through early. TARA'S WARRIOR allowed to settle after breaking awkwardly, advanced to reach contention on the far turn, then faltered in the drive. AMAZO'N was outrun. STANCO set the pace under pressure along the rail to nearing the stretch, then faded. Following a stewards inquiry, WISE ESCAPE was disqualified and placed fifth for interference to SCARBUM in the stretch.
