CANDY CANE chased the pace three wide, moved to take over at the eighth pole, then edged away. HOLIDAY GIRL tracked the pace along the inside, angled out in the stretch and closed to be up for the place. IXTABENTUN reserved along the inside, steadied on the turn, angled out for the drive and finished willingly outside HOLIDAY GIRL for the show. CHARLIE PAPA vied for the lead along the rail to the eighth pole, then weakened. BROWNING unhurried early, angled out widest of all for the stretch run and closed with a belated rally. STREAMIN HEAT vied for the lead outside CHARLIE PAPA to the eighth pole, then gave way. XPECTATION (NZ) off slowly, saved ground and never threatened. BELIEVEINTHEMOMENT failed to menace. SUMMER FLIGHT chased the pace four wide around the turn and tired. RAISINABOVEONLY chased the pace three wide around the turn, then faltered. The rider of IXTABENTUN lodged an objection against the rider of HOLIDAY GIRL for alleged interference in the stretch. The claim of foul was not allowed.
