HEY CUZ stalked the pace along the inside, eased out in the stretch and rallied to catch MORE ANON inside the eighth pole, then was fully extended to

prevail. MORE ANON chased the pace, moved to take over leaving the far turn, then responded when HEY CUZ moved to the fore and held on well for the place. CABEUS rated off the pace, steadied in traffic on the far turn, then closed to gain the show while no threat to the top ones. SIDE PARTY RALPH vied for the lead along the inside into the far turn, continued to make the pace to nearing the top of the stretch, then gave way. ZULU WARRIOR checked when he bumped with ROMANTIC CHANNEL soon after the start, then checked again from between rivals on the first turn, raced four wide around the far turn and failed to menace. SOUP A' FLEET unhurried after breaking slowly, checked to avoid running up on TORMENTO on the far turn and never threatened. TORMENTO was tracking the pace when taken up in behind STRAIGHTSUCCESS on the far turn and failed to recover. EXPLOSIVE IMAGE was not a factor. COSSIO reserved off the pace, steadied in traffic on the backstretch, advanced four wide around the far turn to reach contention, then tired. ROMANTIC CHANNEL checked when he bumped with ZULU WARRIOR soon after the start, then was checked again when very rank racing into the first turn, rushed up along the outside down the backstretch to chase the leaders three wide around the far turn, then faltered. STRAIGHTSUCCESS vied for the lead outside SIDE PARTY RALPH into the far turn, then stopped abruptly.
