SEVE chased the pace, moved up entering the turn to vie with UNBRIDLED FIRE, then bumped hard with that rival twice in the stretch and edged away. UNBRIDLED FIRE vied for the lead three wide, bumped soundly with SEVE a couple of times in the stretch, then couldn't stay with that rival while holding the place. TREND SETTER off slowly, tracked the pace along the inside, angled four wide on the turn while advancing to loom a threat in midstretch, then weakened. PUSHINGONASTRING allowed to settle, raced four wide around the turn and closed with a mild response. REDEMPTION ROAD pressed the pace along the rail to midway of the turn, then tired. HORSESHOE LAKE failed to menace. MR. SEGRETTO raced three wide and faltered. MORDI'S MIRACLE broke slowly, then was rank and steadied a couple of times in behind horses on the backstretch, angled out to race five wide around the turn and dropped back. PIRATESINPARADISE showed early foot and faded. ROCKFIELD was done early. ROYAL DISTINCTION up close early, stopped. THERE WAS A STEWARDS INQUIRY AND THE RIDER OF UNBRIDLED FIRE LODGED AN OBJECTION AGAINST THE RIDER OF SEVE FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
