**Footnotes**

LABOR UNION steadied in the early going, saved ground around the far turn, angled out and rallied to catch INCALZANDO in early stretch, then drew away through the final eighth. PRIME REALESTATE rated off the pace, steadied in behind rivals entering the far turn, was angled to the inside and closed to be up for the place while no match for the winner. GO WEST BERT reserved after being steadied in behind rivals in the early going, advanced around the far turn to loom a threat in the stretch but couldn't keep pace with the winner while just being edged for the place. BRAVE APACHE showed early foot, eased back racing on the first turn, raced three wide around the far turn and improved his position without threatening. COVE STAR unhurried early, passed tired rivals. INCALZANDO chased the pace, moved to gain a slim lead entering the stretch, then tired. JUST A WARNING set the pace along the rail to nearing

the stretch, then faltered. NOVO SECRETO failed to menace. HENNESY EXPRESS tracked the pace three wide to the far turn, then faded. STREAKIN DEACON steadied entering and on the first turn, tracked the pace into the far turn, then had nothing left. BULLSEYE BOY was outrun. SON OF A CYBIL steadied in the early going and was never a factor.
