Footnotes

DICED N SLICED reserved racing along the rail, rallied and slipped through inside STORMY LAKE to take over leaving the turn, opened a clear lead, then was all out to just last over LACIE SLEW. The latter, rated off the pace, angled five wide on the turn, then rallied to just miss. SUAVE ROYALTY raced with the pace four wide into the stretch, then weakened. DAYANARA ROSE pressed the pace three wide around the turn, then gave way. STORMY LAKE (ARG) showed speed off the rail to nearing the stretch, then tired. BEST TIGRESS saved ground and faltered. MY PREFERRED broke in the air, chased the pace five wide into the turn, then faded and was eased in the final eighth.
