**Footnotes**

POLITICAL JUSTICE broke readily, sped to the fore outside foes, then shifted sharply to the inside once gaining a clear advantage, dictated the pace on a narrow margin racing into the turn, continued with a steady response to extend that advantage while shifting out a bit racing into upper stretch, drifted out, then inwards under some pressure racing past midstretch but maintained a clear advantage to the end under firm encouragement. POCO MAN tracked the leaders inside foes in the second flight early, shifted off the rail nearing upper stretch while being prompted to advance and continued with a mild bid between foes to late stages to narrowly prevail for the place honors. JAVA MAN, in touch with the leaders three deep between foes in the opening stages, was urged to maintain striking distance in that path racing into the turn but weakened outside foes racing through the stretch while continuing well enough to earn a share. BEER GARDEN tracked the leaders between foes in the second flight in the opening half, angled to the rail racing through the turn, saved ground gaining some position racing into upper stretch but had no final kick. REVELATIONIST, urged to contend inside foes from the break, shifted off the rail while moving to prompt the pacesetter between foes racing through the backstretch into the turn but gave way racing into upper stretch. MEGALITH, within striking distance four deep in the opening stages, continued outside foes into the bend and steadily faded from contention. BAR MAGIC, shuffled back avoiding close quarters at the start, was collected to track the leaders three deep in second flight but never mounted a serious challenge.
