SUNRISE KITTY set the pace under pressure outside PHYLLIS ANN, then responded when challenged by TO MY VALENTINE through the stretch and held on gamely to prevail. TO MY VALENTINE (FR) tracked the pace, made a run to try SUNRISE KITTY through the stretch but couldn't get by that rival. STARSHIP PLAYGIRL reserved racing along the rail, finished willingly to be up for the show. FEARLESS JACQ (IRE) rated off the pace after breaking slowly, advanced to loom a threat in midstretch but couldn't gain late. HAPPY VOYAGE chased the pace four wide into the stretch but had no late response. FAB FLOWERS outrun after ducking in at the start, angled to the outside in the stretch and closed well. ROSIE RED chased the pace three wide into the stretch, then weakened. PHYLLIS ANN pressed the pace along the rail into the stretch and tired. AMETHYST failed to menace. CASE CRACKER off slowly, showed early foot and faded.
