Footnotes

STARSHIP WILDCAT quickly moved to the fore while angling over to the inside, set the pace under pressure along the inside, drifted out bumping THE CHILL ZONE soundly in the stretch, then lasted over INDIRECTLY A. P. The latter, reserved racing along the rail, rallied to reach STARSHIP WILDCAT in deep stretch but couldn't get by that rival. SOUTHPAW SLAMMER chased the pace into the stretch, then closed with a mild response to be just up for the show. THE CHILL ZONE pressed the pace outside STARSHIP WILDCAT, then was bumped hard by that rival inside the eighth pole and weakened. GIBSON allowed to settle, swung out for the stretch run and found his best stride late. DON'T SAY NO outrun early, closed ground late without threatening. FOREST STATION reserved after being steadied in traffic on the backstretch, saved ground and failed to menace. STRIKE THE TIGER unhurried early,

swung wide for the stretch run and closed with a belated rally. ARI'S PRIDE was not a factor. DOGWOODS LANCE chased the pace three wide into the stretch, then tired. STARSHIP SULU showed brief speed and faltered. FOLLOWING A STEWARDS INQUIRY STARSHIP WILDCAT WAS DISQUALIFIED AND PLACED FOR INTERFERENCE TO THE CHILL ZONE IN THE STRETCH.
