SOUTHERN DUNN chased the pace along the rail, moved through inside VIVI'S PARTY GIRL to gain command on the turn, then drew off through the stretch under pressure. DOLCE LUNA chased the early pace, dropped back racing around the turn, then came on to gain the place while no match for the winner. BLACK HEIR stalked the pace, advanced four wide around the turn to reach the attending position, then tired. WILDCAT LILY broke a step slowly, moved up quickly to chase the pace three wide around the turn, then faltered. E SVEIKATA was done early. VIVI'S PARTY GIRL bobbled at the start, showed speed off the rail into the turn and faded. POMPOUS MISS showed brief speed and had nothing left.
