Footnotes

HEAVEN'S FLAME showed speed along the inside into the stretch, then increased her margin to the wire when asked. MISS WILLOW chased the winner into the stretch but couldn't stay with that rival while clearly second best. STEADY SLEW reserved after being caught in tight at the start, advanced along the inside around the turn to reach contention but couldn't keep pace with the top ones. ENTICING STAR steadied from close quarters at the start, saved ground and improved her position. ADJUSTING chased the pace three wide around the turn and tired. GOLDEN POLICY was not a factor. MAX'S SONG well placed early, raced four wide around the turn and faltered. TIME TO INDULGE unhurried after lunging at the start, was saving ground when checked on the turn and never threatened. FORENSIC EDGE was outrun. SUAVE ROYALTY raced three wide and faded.
