Footnotes

GRAND CENTRAL rated off the pace, raced four wide around the turn, rallied to gain the lead at the eighth pole, then drifted in under right-handed pressure inside the sixteenth pole impeding IL DIVO, then drew clear. MY PAL GRAPPO chased the pace, moved up to duel for the lead into the stretch, then was bumped late by IL DIVO and outfinished. IL DIVO broke slowly, chased the pace three wide around the turn, moved up to duel for the lead between horses, then bumped with MY PAL GRAPPO when forced in late, clipped heels with GRAND CENTRAL and gave way. SCOTCHONHEROCKS chased the pace along the rail, moved up to duel for the lead in the stretch, then was tiring when steadied from inside MY PAL GRAPPO at the sixteenth pole. MASTER TASSEL unhurried after being steadied in the chute, improved his position without threatening. GRAND GULCH failed to menace. NATURES COVE ROAD was not a factor. GRAEME OF GOLD was outrun. THE REAL PRINCE showed early foot and faltered. NANA'S APPEAL showed speed off the rail into the turn, faded and was eased in the final eighth. Following a stewards inquiry and claims of foul by the riders of MY PAL GRAPPO and IL DIVO, GRAND CENTRAL was disqualified and placed third for causing interference inside the sixteenth pole. The rider of IL DIVO also lodged an objection against the

rider of MY PAL GRAPPO for interference in the stretch and the rider of SCOTCHONTEROCKS lodged an objection against the rider of MY PAL GRAPPO for interference at the sixteenth pole. Both those claims of foul were not allowed.
