Footnotes

DANCES FOR TIPS chased the pace, angled four wide on the turn, then rallied outside MYMISSJULIAC to be up late. MYMISSJULIAC chased the pace three wide around the turn, rallied with DANCES FOR TIPS to reach even terms for command in deep stretch but was edged to the wire by that rival. MISS SHANGAI showed speed off the rail to deep stretch and gave way. JUDGE'S PRIDE off slowly, tracked the leaders along the inside into the stretch but didn't do enough late. KIT CAT CATON rated off the pace, steadied entering the turn, raced three wide into the stretch and finished willingly. STORMY LAKE (ARG) reserved off the pace, steadied from inside KIT CAT CATON entering the turn, raced three wide into the stretch and closed ground late. REGAL BIRD raced four wide around the turn and gained some ground in the drive. BLOOD DIAMONDS saved ground to no avail. SPLIT THE CLOUDS failed to menace. MACUMBIRA was no factor while racing four wide. CLASSIC LAKE outrun after being steadied at the start, was steadied again to avoid

the fallen rider in the stretch. GIRL GLITTER pressed the pace along the inside, then was contesting the lead when she ducked through the rail in early stretch and unseated her rider. There was a stewards inquiry into the fallen rider.
