**Footnotes**

SWEETSOUTHERNQUEEN reserved early, raced three wide around the far turn, rallied to gain the lead inside the eighth pole and drew clear. SNICKLEBRITCHES chased the pace, made a run to reach even terms for command with HURRICANE ANNIE on the far turn, vied with that rival to inside the eighth pole, then couldn't stay with the winner while saving the place. IRISH COVE tracked the pace along the rail, was checked from tight quarters entering the far turn, continued to save ground into the stretch, eased out and closed to just miss the place. DOTTIE BOOTH tracked the pace four wide, advanced to loom a threat on the far turn but had no further response. TRIGGER FISH LANE reserved while saving ground, angled out for the stretch run and passed tired rivals. ULTIMATE EVENT unhurried after being steadied in the early going, steadied again entering the far turn and failed to menace. HURRICANE ANNIE sprinted to a clear lead along the rail, responded when challenged by SNICKLEBRITCHES on the far turn, vied with that rival to inside the eighth pole and tired. GATOR'S TRACKS rated off the pace after being steadied in the early going, angled to the rail while advancing leaving the far turn, then was taken up from the eighth pole to the sixteenth pole when unable to get through inside HURRICANE ANNIE and failed to recover. DAZZLING PRINCESS chased the pace to the far turn and faltered. JOYFUL ACRES was outrun after hesitating at the start.
