VALID SILK set the pace under pressure outside DIABLO'S BOBETT, edged away after entering the stretch and proved best under urging. BLOODLINES settled off the pace, split rivals in the drive and was up for the place. PAY THE GREEN advanced four wide around the turn, then lacked the needed late response while being edged for the place. DIABLO'S BOBETT hustled up the inside to force the pace and weakened. SUMMER CLASSIC unhurried early, swung out for the stretch run and failed to rally. FREEREPY outrun early, clipped KISCO's heels on the turn, then continued on wide while not a factor. GLITTER SPACE faltered after showing brief foot. MOUNTAIN SEA was no menace. JUDICIAL REVIEW with the pace while three wide, faded. KISCO raced four wide on the turn, stopped and returned lame.
