DEL MAR SHOW reserved early, rallied four wide to take over on the far turn and drew clear under urging. LEGAL JOUSTING (IRE) off slowly, steadied when caught in tight early, advanced along the inside on the far turn, angled out and closed willingly for the place. ANOTHER SUPRISE rallied along the inside entering the far turn, came outside the tiring PUMA to reach near even terms for command, then weakened in the drive. FULL FLOW outrun early, passed tired rivals. DOUANIER chased the pace, made a run three wide on the far turn to reach even terms for command, then tired in the drive. WONDER WEAPON unhurried early, saved ground into the stretch and had no late response. TIGER LION failed to menace. LORD OF THE DANCE rated off the pace, checked in behind the leaders midway of the far turn and faltered. CHIEF BIDDER showed little. DR. WILLIS was not a factor. PUMA made the pace along the hedge to midway of the far turn and faded. MONTEZUMA'S GOLD chased the pace into the far turn, stopped and was eased in the final eighth.
