BRUNILDA (ARG) reserved after being steadied along the inside on the first turn, angled out four wide on the far turn, rallied to reach even terms for command with PATH OF THUNDER just inside the eighth pole, then responded to pressure and edged that rival to the wire. PATH OF THUNDER rated off the pace, raced three wide on the far turn, rallied to reach even terms for command with BRUNILDA just inside the eighth pole and continued on gamely while being edged to the wire. NATALIE BEACH (ARG) allowed to settle, angled to the outside entering the stretch and closed to be up for the show while unable to get to the top ones. HIGH COURT (BRZ) unhurried early, split rivals in the stretch and closed with a mild rally. MONA ROSE outrun early, swung out for the stretch run and closed some ground without threatening. PLEASE TAKE ME OUT set the pace along the rail to the eighth pole and gave way. CAT ALERT stalked the pace, made a run at the lead in midstretch, then weakened. ACLASSYSASSYLASSY in good position while saving ground, couldn't keep pace in the drive. CHANGING WORLD chased the pace into the far turn and tired. MY RO well placed behind the leaders, angled to the inside on the far turn and faltered.
