RICHIE RULES bobbled at the start, set the pace under pressure off the rail to inside the eighth pole, opened a clear lead, then was fully extended to last over CHAIRMAN TUCKER. The latter, chased the pace along the rail, altered course outside the leaders in early stretch, then was gaining on the winner at the finish. FULL LIQUIDITY pressed the pace three wide to inside the eighth pole, then weakened. BASIN STREET chased the leaders into the stretch and tired. SWEET BERNIE bumped with OLD TOWN at the start, chased the pace three wide around the turn and faltered. OLD TOWN bumped with SWEET BERNIE at the start and was not a factor. ORIENTATION reserved off the pace, faded leaving the turn. RASCALLION trailed.
