### Footnotes

BRUSHED BAYOU raced with the early pace, was steadied to avoid running up on rivals after being outmoved on the turn, came on to gain the lead entering the stretch and opened a clear lead, then was fully extended to hold HAPPY HONOREE safe. The latter, broke poorly, tracked the pace along the rail and finished willingly for the place. JILLI'S CAPE showed speed along the inside, then drifted out at the top of the stretch, was straightened away and continued on with good courage to hold the show. LUCKY TRIP steadied in behind rivals on the backstretch, made a run three wide on the turn to reach the leaders, then was floated out by JILLI'S CAPE leaving the turn and gave way. ALBANY COUNTY reserved in striking position off the pace, lacked a late response. HAND ME DOWN off slowly, was not a factor. MY DIXIE DANCER pressed the pace outside JILLI'S CAPE to the quarter pole, then faltered.
