ROMACACA chased the pace, moved to take over nearing the eighth pole, then was all out to prevail. MYSTIC MIRACLE tracked the pace off the rail, eased out for the stretch run and was gaining on the winner at the finish. ANSONG unhurried early, angled out for the stretch run and closed with a mild rally to be up for the show. QUEBRADA SHINER (ARG) tracked the leaders along the rail into the stretch but had no late response. STRIKE IT RICH quickly moved to the fore, made the pace along the rail into the stretch, then tired. STRIKING DANCER saved ground to no avail. FIRST PASSAGE failed to menace.
