JOINEM reserved while saving ground, steadied leaving the far turn, swung out for room at the top of the stretch, then rallied to be up in time. BERGERAC set the pace along the rail, repulsed a bid from MOBILIZER through the stretch but couldn't resist the winner in the final strides. MOBILIZER stalked the pace three wide, made a run at BERGERAC through the stretch but wasn't good enough. LIGHTHOUSE SOUND tracked the pace, eased out in the stretch and closed with a mild response. DECAF AGAIN rated off the pace, lacked a late response. FASTEST MAGICIAN tracked the pace along the inside, was steadied when caught in too close to the rail at the top of the stretch and gave way. FINAL COUNT raced in striking position into the far turn and tired. AUDACITY OF HOPE (GB) prompted the pace outside BERGERAC to the quarter pole, then faltered.
