POSTPONED circled rivals four wide on the far turn, took over inside the eighth pole and was fully extended to prevail. SKIP A GRADE rated close up behind the leaders, angled three wide for the stretch run, rallied to gain a brief lead in midstretch and continued on gamely while being edged to the wire. FAMOUS AGAIN wearing a nasal strip, made the pace under pressure along the inside and weakened in the drive. CATALOG pressed the pace, gained a slim lead on the far turn, then tired. MALAGOT wearing a nasal strip, was reserved early, then lacked the needed late response. SETTLEMENT wearing a nasal strip, was unhurried early, advanced into contention in the stretch, then faltered. BARRAGE well placed after breaking slowly, faded in the stretch run. ARBOR DAY in contention along the rail after breaking awkwardly, was through after a half mile.
