BAKARAT advanced inside for the early lead, rated her speed to the top of the lane, came out a path at that point while being put to pressure and lasted well under steady insistence. SOSSEGO, unhurried early, bid into the turn, eased out for the drive, came inside the winner in deep stretch and finished well while not in time to catch that one. AIUNI rated off the pace inside, advanced toward contention approaching the turn then faltered in the stretch. HUSTLE rated off the pace inside, bid into the turn, eased out near the quarter pole and finished evenly. THIS GAL IS MINE stumbled badly leaving the gate, settled well back from the early pace, made up some ground through the turn then leveled off in the stretch. DANCINGDOWNTHELANE gave chase from off the rail then faded on the turn. BORSA gave chase toward mid track then faded on the turn. MY FRIEND MELINI rated with the early pace off the rail but showed little response on the turn. DANCINGFORDIAMONDS was outrun. BARRINGTON HILLS rated off the pace in mid track, made a mild five wide bid on the turn then weakened. FIRST MANDATE showed only brief early speed before fading. PROSPECTIVE RUN never factored.
