PELEADORA FUERTE chased the pace four wide, rallied to take over nearing the eighth pole, then was fully extended to prevail. LAKESIDE CHAPEL rated off the pace, angled out for the stretch run and rallied for the place. GORGELICIOUS set the pace off the rail into the stretch and weakened. LEMON FEVER chased the pace three wide, made a run to try GORGELICIOUS into the stretch, then gave way. LUCKY AND SWEET failed to menace. WITH MY DADDY showed brief speed along the rail and faded.
