ANGEL'S SEA chased the pace off the rail, moved to gain a slim advantage on the turn, then was all out to prevail. TOTEMTALE chased the pace four wide, made a run to reach ANGEL'S SEA at the quarter pole, then tried that rival through the stretch but was outgamed to the wire. SHERIFF IRA rated off the pace, raced three wide around the turn, then closed with a mild response along the outside to be up for the show. JUST CHILLIN BOSS showed speed three wide, responded when ANGEL'S SEA moved to the fore on the turn, then was tiring when caught in tight briefly between the top ones nearing the eighth pole. STORMY OCEAN stalked the pace off the rail to nearing the stretch, then faltered. TRUE ROMAN raced four wide and faded. ALYSON'S APPLE chased the pace into the turn, then had nothing left. THE RIDER OF JUST CHILLIN BOSS LODGED OBJECTIONS AGAINST THE THE RIDERS OF ANGEL'S SEA AND TOTEMTALE FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
