Footnotes

BACKSEAT MEMORIES settled saving ground, moved up through the second turn, angled out four wide, kicked on well once clear and edged clear. SPIVEY was forwardly placed along the inside, tipped out and bid between horses entering the stretch, was jostled near the three-sixteenths marker when PLENTY OF POPP came out, but kept on well to earn the place. STRAIGHT TOWN settled in hand, ranged up four wide to engage the leaders leaving the second turn, was bumped entering the stretch and flattened during the drive. POCO MAN was unhurried into stride, angled in to save ground near the tail of the field, circled five wide through the second turn, offered a mild bid but failed to sustain the drive. PLENTY OF POPP set the pace along the inside, was collared near the quarter pole, drifted out bumping SPIVEY entering the stretch and gave way readily once headed. ACT OF DIVINITY was unhurried into stride, rallied between horses four wide, offered a mild bid but came up empty entering the stretch. SONG FOREVER prompted the pace two wide through the second turn and dropped out. VIA MARINA was close up three wide for six furlongs and retreated. NIGHTOWL EARLYBIRD contended five wide for a half, stopped and was eased to the wire but walked off.
