**Footnotes**

A. P. DELTA stalked the pace, moved to gain a slim lead on the far turn, then responded when challenged by CLAYTON'S FIND inside the eighth pole and was all out to prevail. CLAYTON'S FIND unhurried early, angled four wide on the far turn to make his run, rallied to reach A. P. DELTA inside the eighth pole, then dueled with that rival while being edged to the wire. TEMPTATION BOUND well placed while saving ground, outfinished the others for the show. ATWAAR unhurried early, rallied three wide on the far turn to loom a threat, then weakened in the drive. TRENTINO tired from good position. DIABLO'S CROWN failed to menace after being outrun early. SKIP A GRADE was not a factor. BELASCO made the pace along the inside into the far turn and faltered. GONE NORTH prompted the pace, then was tiring when steadied on the far turn and faded.
