AUTHENTICITY vied for the lead to the outside of EVENIGN SURPRISE in hand, drew away at will leaving the second turn, widened without asking to prove much the best. EVENING SURPRISE disputed the pace along the inside, was no match for the winner leaving the turn, but stayed on to earn the place. CYPRESS POND contended off of the inside, advanced between horses through the second turn, came three wide and was along for the show. HIGHLAND SARA settled between horses at the back of the pack, angled out leaving the second turn and finished with a belated gain. ANNIE RUSSELL settled saving ground, moved up through the second turn, was bottled up in traffic near the five-sixteenths pole and flattened out entering the stretch. CONSTRICTOR was close up four wide for six furlongs and dropped out. BEST GIFT OF ALL settled four wide and lacked a response.
