AARON'S ROD chased the pace, moved up to engage LUCRATIVE DEAL leaving the turn, then bumped with that rival while dueling through the stretch and prevailed. LUCRATIVE DEAL set the pace under pressure outside MAKALOLO CAT, responded when challenged by AARON'S ROD, then bumped with that one while dueling through the stretch and was just edged to the wire. IDENTICAL reserved racing along the inside, eased out in the stretch and finished willingly for the show. OSTIN'S MIRACLE unhurried early, angled out for the drive and rallied to just miss the show. MAKALOLO CAT bumped soundly with SPICY VOW at the start, pressed the pace along the inside into the turn, then tired. SPICY VOW was not a factor after being bounced around at the start. SERAPI CAT failed to menace. SARAH PICKED IT bumped hard with SPICY VOW at the start, chased the pace four wide into the turn and faltered. STORM CABIN chased the pace three wide to midway of the turn, then faded. HANGING IN THERE was through early after lunging at the start. The rider of LUCRATIVE DEAL lodged an objection against the rider of AARON'S ROD for alleged interference in the stretch. The claim of foul was not allowed.
