**Footnotes**

CASA TUA stalked outside a rival, rallied three wide into the stretch, gained steadily outside and was along in time. RUNNING IN CHOOS vied inside, dug in gamely past midstretch and was caught late. ARTIE'S PARTY vied outside for command and stayed on well to the end. ZEENUT raced off the pace inside and rallied between horses in the stretch. VIXEN'S ROAR raced between foes throughout and gained mildly in the stretch. HIGH ON KITTEN had a

three wide trip and finished evenly. WALK SOFTLY had a three wide trip and failed to threaten. IMPERIAL JIVE pulled inside in the early stages and lacked a rally. SMART FARMING raced off the pace between rivals and failed to rally. LILY LYNN raced off the pace, three wide on the far turn and did not factor. CINDY'S JOY raced off the pace, moved up four wide on the far turn and did not factor. PEGASUS SONG saved ground and tired.
