YAMIPA hit the gate at the start, chased the pace into the stretch and weakened. BROWN EYED WOMAN failed to menace. DON'T DIGRESS wearing a nasal strip, chased the pace three wide around the turn and tired. ALICIA D. showed early speed and stopped.
