**Footnotes**

QUICK DELIVERY unhurried early, raced three wide around the far turn, came outside the leaders for the stretch run, rallied to gain the lead at the sixteenth pole, then just lasted over DEVON ROCK. The latter, reserved off the pace, was taken up when trapped in behind rivals at the top of the stretch, angled out for racing room and rallied to just miss. LISTON outrun after lunging at the start, swung wide for the stretch run and finished full of run to just miss catching the top ones. STAY RED allowed to settle, raced three wide around the far turn, made a run to loom a threat inside the eighth pole but was outfinished. TELLUM BERTO set the pace along the rail, responded when challenged by ESTIMATE on the far turn, then dueled with that rival to the sixteenth pole and weakened. ESTIMATE (FR) chased the pace, made a run to engage TELLUM BERTO at the quarter pole, then dueled with that rival to the sixteenth pole and gave way. LONGBOARDER tracked the pace, then was checked when unable to split rivals at the eighth pole and failed to recover. PISCITELLI taken in hand along the rail, steadied racing into the first turn, checked to avoid heels on the first turn, steadied again in behind rivals racing down the backstretch, then was blocked through the stretch and unable to threaten. STORM ISLAND chased the pace three wide into the stretch and tired. MUTINY steadied on the first turn, stalked the pace along the rail into the stretch and failed.
