BLAZING C. E. O. tracked the pace three wide and rallied through the drive to draw clear late. MISS LUCY forced the pace outside APRIL INVITATION and gained the place. I LUFF LOUISA, hit the gate at the start, raced four wide around the turn and rallied to best the others. APRIL INVITATION set the pace under pressure along the rail and weakened. CERTAIN PHONE, unhurried early, was no threat while racing wide in the stretch. BERING AFFAIR, off slowly, was outrun while saving ground. HIGH STEPPER chased the pace and faltered. SANDY GIRL was through early.
