Footnotes

RESOUNDINGLY tracked the pace three wide, rallied to take over nearing the eighth pole, then drew off. MISS KITTEN outrun after breaking slowly, advanced into contention around the far turn, then was no match for the winner while edging PROUDROAD TO GLORY. The latter, unhurried after a slow start, swung out leaving the far turn, then was forced very wide in the stretch, recovered and closed to just miss the place. FLY BYE WILDCAT quickly sprinted to a clear lead, made the pace along the inside into the stretch, then gave way. CEYLON STAR tracked the pace along the inside into the stretch and tired. PLATINUM FUTURES chased the pace to the quarter pole, then drifted out badly through the stretch bothering several rivals while faltering. ALLTHETIME rated in striking position, failed to recover after being forced wide and checked in the stretch. MYRA RACING QUEEN allowed to settle, was

steadied when forced wide in the stretch and never threatened. RACHEL LEE well placed while racing three wide, was checked when forced wide in the stretch and dropped back. FANDANGO STEPS was outrun. FINE WAY TO FLY was not a factor. FLY AWAY MARIJA was through early. Following a stewards inquiry, PLATINUM FUTURES was disqualified and placed ninth for interference to several rivals in the stretch.
