PETECAROL vied for the lead outside CITIZEN'S ARREST, responded when challenged by PRAY FOR ACTION at the quarter pole, then dueled with that rival to the wire and prevailed in a game effort. PRAY FOR ACTION chased the pace three wide, moved up to engage PETECAROL at the quarter pole, then dueled with that rival and was just edged to the wire. GINGER'S JOE well placed in behind the leaders, couldn't keep pace in the drive. BUZZ TOWN failed to menace. BOOK SAYS YES was not a factor. CITIZEN'S ARREST vied for the lead along the rail to nearing the quarter pole, then tired. HALO DOCTOR JOE steadied on the backstretch, saved ground around the turn and faltered. HOOPLA raced three wide and faded.
