RODAN was bumped at the start, stalked outside, bid three wide at the quarter pole, edged away and held under urging. TANZANA tracked inside, waited a bit for room nearing the quarter pole, angled out and rallied outside. FORWARD OBSERVER dueled inside and weakened. TRIPLE A. RATING was away alertly, dueled outside and weakened. ROMAN BAY chased between foes and failed to respond. JUJU was bumped at the start, raced inside and had no rally. QUICK APPEAL broke in bumping RODAN at the start, then did not factor. SOLAR D'ORO chased outside and faded.
