Footnotes

APPLE CHARLOTTE saved ground off the pace, moved up between rivals past the half, went back to the rail, waited for room in tight quarters, slipped through on the rail at the sixteenth pole and pulled away. CRESCENDA was bumped at the start, raced three wide, came through between rivals in upper stretch and closed well outside. SUN PENNIES set the pace, dug in stubbornly and was outfinished. CAMINADORA broke in bumping CRESCENDA at the break, stalked outside a rival, raced on the rail in the stretch and rallied mildly. DREAMED TO DREAM hopped at the start, saved ground and closed belatedly. LAKESIDE CHAPEL stalked outside, came four wide into the lane and lacked a rally. HEARTED tracked the pacesetter, made a bid and weakened. JERSEY SHORE GIRL settled off the rail, made a three wide move on the turn, came five wide into the stretch and tired. FOR TERINA raced three wide on the far turn and did not factor. DONAMIA raced close up inside and faded.
