STAKES Canadian Turf S. Grade 3 - Thoroughbred

FOR FOUR YEAR OLDS AND UPWARD. Free nomination by Saturday, February 6, 2010, \$1,500 to pass the entry box and \$1,500 additional to start, with \$150,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$90,000, \$30,000 to second, \$15,000 to third, \$7,500 to fourth, \$4,500 to fifth and \$3,000 to sixth. Supplemental nominations may be at time of entry at a fee of \$6,000, which includes entry and starting fees. Weight: 124 lbs. Non-winners of a graded/group sweepstakes at a mile or over on the turf in 2009-2010 allowed 2 lbs.; of a sweepstakes at a mile or over on the turf in 2009-2010 allowed 4 lbs., \$45,000 at a mile or over since July 1, 6 lbs. Starters to be named through the entry box by the usual time of closing. In the event this stakes is taken off the turf, it may be subject to downgrading upon review of the Graded Stakes Committee. Trophy to the winning owner. Closed Saturday, February 6, 2010 with 52 nominations. (If deemed inadvisable to run this race over the turf course, it will be run on the main track at One Mile) (Rail at 72 feet).

COURAGEOUS CAT stalked the leader in the two path, bid at the quarter pole, responded when asked, took a short lead and dug in determinedly to hold on. CHEROKEE ARTIST saved ground off the pace, advanced inside on the turn, angled out entering the stretch and closed gamely outside. JET PROPULSION set the pace, dug in gamely in upper stretch and stayed on well. PICKAPOCKET saved ground racing off the pace and rallied mildly on the rail. LE GRAND CRU tracked inside, came out for the drive and lacked a winning bid. VANQUISHER settled off the rail, raced between horses in the stretch and failed to threaten. STAR PLUS (ARG) settled outside a rival and lacked a rally. MAMBO MEISTER raced inside and failed to respond. RAHY'S ATTORNEY raced off the pace, came three wide into the lane and had no rally.
