Footnotes

VANQUISHER stalked the pace three wide, rallied to gain a slim lead in the stretch, then was all out to hold off TARGET SIGHTED. The latter, rated off the pace, angled out for the stretch run, then rallied while drifting in to VANQUISHER late and missed. VOLCANO RUN reserved racing along the inside, eased out to make a run at the leaders in midstretch, then weakened. LE MANS unhurried early, was forced to wait for room in behind rivals on the far turn, angled out in the stretch and closed with a belated rally. ALMORADI (IRE) allowed to settle, swung out for the stretch run and finished willingly without threatening. MIDNIGHT NOTES rated off the pace, steadied in traffic on the backstretch, then was making a run to reach contention when steadied again in midstretch and flattened out. O WANDERLUST vied for the lead outside DYNAMIC BOY, eased to the inside on the backstretch after clearing that rival, made the pace to nearing the eighth pole and gave way. DYNAMIC BOY vied for the early lead along the inside, eased out to chase O WANDERLUST down the backstretch and around the far turn, then was tiring when steadied from tight quarters in the stretch. GIBSON COUNTY LINE raced three wide and faltered.

THE RIDER OF TARGET SIGHTED LODGED AN OBJECTION AGAINST THE RIDER OF VANQUISHER FOR ALLEGED INTERFERENCE IN DEEP STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
